Remarks & Conditions:

Any THC costs, any Release-/ ISPS charges or any Quay rent charges as imposed by the shipping lines on import or export orders which are not included in the agreed NewPort freight rate agreement are for the account of the Consignee (import) or Shipper (Export) as per outlay.

Our services do NOT include costs for mandatory container scanning by the customs authorities or any costs related to customs clearance like specific documentation, taxes, import duties or any licenses.

All related costs for product residue removal and heel disposal after discharge that exceed 20 liters are for the consignees account as per outlay including those of the first 20 liters.

In case NewPort is requested to execute additional services without a valid price agreement already in place, automatically above charges will be applicable for those services.

ECD: Every tank comes with an EFTCO Cleaning Certificate with issue date of at least 7 days old relative to the scheduled loading date (if door) or release date from depot (if port). If requested for an ECD with issue date of less, reclean will applies.

Scheduled loading/discharge reservations may be cancelled (or changed) up 10AM on the prior day before loading/discharge at no additional trucking charge.

No-show charges of Shipping line may arise and will be billed quote-on-quote.

Cancellation/change of transport after 10.00 AM prior day loading/discharge will be billed for the full transportation charges (which may include also rail/barge and not only truck).
